

Unitil Declares Common Stock Dividend

Hampton, N.H. - March 18, 1999 - Unitil Corporation (AMEX:UTL) today announced that its Board of Directors declared the regular quarterly dividend on the Company's common stock of \$0.345 per share, payable on May 14, 1999 to shareholders of record on April 30, 1999. This quarterly dividend results in a current effective annual dividend rate of \$1.38 per share.
