Hampton, NH; June 21, 2000 – Unitil Corporation (AMEX:UTL) today announced that its Board of Directors declared the regular quarterly dividend on the Company's common stock of \$0.345 per share, payable on August 15, 2000 to shareholders of record on August 1, 2000. This quarterly dividend results in a current effective annual dividend rate of \$1.38 per share.
